0. Introduction

Thank you for visiting us and we hope that you enjoy exploring our website <https://traxes.io> (hereinafter referred to as the '**website**').

In the framework of the website, Elia Transmission Belgium (hereinafter referred to as '**Elia**' , '**we**' , '**our**') undertakes to protect and respect your privacy (hereinafter referred to as '**you**' , '**your**'). To this end, Elia protects the personal data of its online users/visitors collected via cookies, tags or tracers (hereinafter generally referred to as '**cookies**') and processes said data with the greatest possible care.

1. Identity of the controller

The controller of your personal data is Elia Transmission Belgium, having its registered office at Boulevard de l'Empereur 20, 1000 Brussels, Belgium, a public limited company under Belgian law, registered in the Crossroads Bank for Enterprises under the number 0731.852.231, for the website <https://traxes.io>

2. About cookies

Cookies are small data files that are downloaded to your device (e.g. a tablet, smartphone, PC or laptop) when you visit our website. They may collect information about your use of the website or allow us to identify you and your device when you return to our website at a later date. Cookies also enable us to recognize your device. 3. What types of cookies do we use?

We use both session cookies and persistent cookies on our website.

We also use first-party and third-party cookies. First-party cookies are Elia's cookies, while third party cookies are set by websites that belong to a domain differing to that displayed in the address bar when you visit an Elia website.

We also make use of third-party requests , which are requests made to external servers to display content from other applications or later though these applications do not install any cookies, they may still collect information about visitors via settings.

We use the following types of cookies on our website:

- Strictly necessary cookies are essential for allowing visitors to browse our website and use its functions. As they are a technical necessity, these cookies are installed once you access the website and cannot be rejected.

- Analytical/performance cookies collect information about how you use our website (e.g. the web pages/functions you visit/use most often). They help us improve the operation of the website and can be accepted or rejected.

4. Cookies used on this website

This section categorizes and describes the various cookies used on this website based on their purpose, type and supplier, where applicable.

1. Strictly necessary cookies

AspNetCore.Antiforgery (AspNetCore.Antiforgery)

Purpose: Essential for website security, used to protect against Cross-Site Request Forgery (CSRF) attacks. It helps ensure that requests made to the server originate from legitimate sources.

Legal basis for processing: legitimate interest (Article 6(1)(f)) General Data Protection Regulation ('GDPR')

Duration: Session

Cookie Consent (tx_cookie_preferences)

Purpose: Stores the user's cookie consent state for the current domain in local storage

Cookie Owner: traxes.io

Legal basis for processing: legitimate interest (Article 6(1)(f)) General Data Protection Regulation ('GDPR')

Duration: 1 year

Session expiration date (TraXesSessionExpirationDate)

Purpose: Stores the time the session should end (user be logged out) in local storage

Legal basis for processing: legitimate interest (Article 6(1)(f)) General Data Protection Regulation ('GDPR')

Duration: 1 year

Application version (appVersion)

Purpose: Stores the user's application version

Cookie Owner: traxes.io

Legal basis for processing: legitimate interest (Article 6(1)(f)) General Data Protection Regulation ('GDPR')

Duration: 1 year

Browser language (tx_culture)

Purpose: Stores the user's default browser language

Cookie Owner: traxes.io

Legal basis for processing: legitimate interest (Article 6(1)(f)) General Data Protection Regulation ('GDPR')

Duration: 1 year

Authentication cookie (__traxesPortal, __traxesPortalC1, __traxesPortalC2)

Purpose: Stores the user's authentication information

Legal basis for processing: legitimate interest (Article 6(1)(f)) General Data Protection Regulation ('GDPR')

Duration: Session

hjSessionUser{site_id}	Set when a user first lands on a page. Persists the Hotjar User ID which is unique to that site. Hotjar does not track users across different sites. Ensures data from subsequent visits to the same site are attributed to the same user ID.	365 days
hjSession{site_id}	Holds current session data. Ensures subsequent requests in the session window are attributed to the same session.	30 minutes

Matomo Analytics

Matomo Analytics (_pk_id, _pk_ses, _pk_ref, _pk_cvar, _pk_hsr) and Matomo Tag Manager (_mtm)

Purpose: to collect information about how visitors use this website. We use the information to compile reports and to help us improve the website. The cookies collect information in an anonymous form, including the number of visitors to the website, which page directed the visitors to this website, and the pages they visited.

_pk_ses, _pk_cvar, _pk_hsr	Short lived cookies used to temporarily store data for the visit	<u>30 minutes</u> ¹
mtm_consent (or mtm_consent_removed)	Created to remember that consent was given (or removed) by the user	<u>30 years</u> ¹
mtm_cookie_consent	Created to remember that consent for storing and using cookies was given by the user	<u>30 years</u> ¹
matomo_ignore	Used when you exclude yourself from being tracked (opt-out)	<u>30 years</u> ¹
matomo_sessid	Used for the opt-out feature (nonce to help prevent CSRF security issues)	<u>14 days</u> ¹

6. Your rights

You have certain rights regarding the data we hold about you.

7. Retention period of collected data

The retention period of the data collected by various cookies may vary depending on whether the cookie is installed by Elia or by third parties. We are not responsible for the retention period of third-party cookies.

Any personal data collected by Elia will not be retained for longer than is strictly necessary for the purposes set out in this Policy.

Beyond that, said data will be deleted at the end of the retention period, unless a longer period is permitted or required pursuant to a legal or regulatory obligation, or if the data are subject to a process of anonymisation in order to make it impossible to 're-identify' individuals. As data that have undergone this process are no longer personal, they can be kept for an unspecified period of time and can be exploited, specifically to produce statistical reports.
